#### Sterilization and Infection Control

 Sterilization Units: RCoD has dedicated sterilization area (CSSD) with autoclaves and ultrasonic cleaners to ensure all instruments are thoroughly disinfected.



Infection Control Protocols: RCoD follows standard infection control practices that includes the
use of personal protective equipment (PPE), hand hygiene protocols, and the safe disposal of
medical waste.

## Patient Management and Record-Keeping
